369 Present

370 Apologies

Apologies for absence received from Cllrs K Sutherland and P Marshall.

371 Minutes

The Minutes of the Council Meeting held on 21<sup>st</sup> February 2011 were read, confirmed as a correct record and signed by the Chair.

372 Disclosure of Interests

373 Correspondence

The Clerk read from the attached correspondence list and the correspondence was noted.

374 Reports from Committee Meetings

There have been no Committee Meetings since the last Full Council Meeting.

375 Reports on Sub-Committee Meetings Held

There were no reports from Sub-Committee Meetings.

376 Reports from Outside Meetings

Cllr Nash attended the Westham and Pevensy Local Transport Partnership, they are currently working on operating independently and gaining charity status.

Cllrs B Molog and Garner attended the East Sussex Area Forum which outlined the Localism Bill and Century 21.

C Cllr T Freebody entered the room.

Cllr B Molog attended an NHS meeting which she found very interesting.

Cllr T Comerford also attended the East Sussex Area Forum but found that Localism is currently lacking in detail. He also asked if Link can be invited to the next Annual Parish Meeting.

Cllrs Garner and Parsons attended a Speedwatch Meeting and will report back to the Parish Council when they know more.

The meeting was then suspended.

377 Report from the PCSO

Cllr Parsons read from the police report which had been previously distributed to councillors.

378 Reports from County/District Councillors

C Cllr Tony Freebody attended a Cabinet Meeting on the 8<sup>th</sup> March 2011. It was proposed that concessionary fares will continue to start at 9.00am. It had been suggested they start at 9.30am as part of the budget cuts. Childrens' Services were recently inspected by Ofsted and found to be performing well and East Sussex Fire and Rescue is considering merging with West Sussex.

379 Questions from Members of the Public

S Macmillan from Foxes Hollow Residents' Association asked an update about the entrance wall at Foxes Hollow. Mr Garner explained that the wall is moving and the movement is being monitored by the Risk Assessment Working Party.

A Painter asked what plans the Community Council has for Adur Park.

P Britton asked why the Council changed its name and after much discussion it was agreed to revisit this decision in October.

M Deschamps asked if the Developers will keep the roads clean whilst the houses are built at Miller's Keep.

The meeting was then re-opened.

380 Emergency Plan - Update

Operation Watermark has now taken place and issue 2, which includes Amendment 12, of the Emergency Plan is ready for distribution. This was resolved unanimously.

381 Risk Assessment Update

382 Parish Clerk – Job title change

As the decision to change the Council name is being reviewed it was agreed to defer this item until after the review.

383 Security at Tillingham Way

The Community Council, Red Dyke Residents' Association and nearby residents have still to carry out a street meeting to look into the residents' concerns. Red Dyke Residents' Association will let the Clerk know when they have spoken to their residents and then the meeting will be arranged.

384 No Cold Calling Sign

The potential new owner of Elsie Cottage asked the Community Council to move or remove the no cold calling sign outside her cottage.

It was **RESOLVED** unanimously that the cold calling sign will remain in place.

385 Newsletter

Councillors looked at the new design for the newsletter proposed by Cllr Blaker.

It was **RESOLVED** to accept the new version, the print will be larger, the outer and inner sheets will be colour and the inside sheets will be black and white. Cllrs Parsons and B Molog will edit and print the newsletter and arrange distribution.

386 Questions From Members

The Clerk made Councillors aware that Active Play now costs £45 a session.

The Clerk also made Councillors aware they will need to have a Neighbourhood Plan in place when the Localism Bill is passed. As part of the changes Developers will have the right to talk to Town and Parish Councils before they submit their planning applications. In light of this Councillors agreed that the Chair and Clerk can meet Rydons about a potential new development south of Rattle Road.

Cllr Saxby asked the Clerk to ask the police to remove the accident signs in Hankham.

Cllr B Molog asked the Council to contact Hilliers to advise them of the new name and to make them aware they are in this parish and not Polegate or Pevensy..
