## WESTHAM PARISH COUNCIL NEWS

### **At the Full Council Meeting in September Councillors resolved:**

To adopt the Second Risk Assessment Report on Foxes Hollow Wall and agreed to get prices to repair the wall as per the Report.

To formally adopt the principles in the Pond Report, look into what can be done, get costings and report back to the Full Council.

To purchase three new open concrete bins for Stone Cross at a total cost of £1006.

To Celebrate the Queen's Diamond Jubilee with a Picnic in the Park, the logistics of which will be delegated to the Parks and Open Spaces Committee.

To support Red Dyke Residents' Association with its request to house bags of grit in weather and help where it can.

To set up a Sub-Committee from the Parks and Open Spaces Committee to look at facilities in Adur Park.

To make upgrading the play parks a priority when spare money is available.

### **At the Full Council Meeting in October Councillors resolved:**

To retain the name Westham Parish Council

The Youth Shelter remains in its current position in Adur Park and is reviewed Sept 2012.

**At the Planning Committee Meeting** attended by many residents in November, Councillors **unanimously objected** to the planning application for the proposed **Shepham Lane Wind Farm** for the following reasons;

Proximity to residential housing/schools, Health, Safety and Economy, to protect the Natural Environment and flawed Data.

The Council also stated in their response to Wealden Planning Authority:

We are deeply concerned that Councillors on the Planning Committee (Wealden) should not see this application as a 'one off' local problem but should see the implications for the whole of Wealden and East Sussex.

We trust that Wealden will seek further technical and scientific expertise as this is an application outside the normal remits received in Planning Applications.

The residents who have written opposing the proposals speak from a wide fund of personal knowledge whilst we at Westham Parish Council have taken full cognisance of a range of professional advice and expertise.

**This planning application is due to be heard by Wealden Council Planning Committee in January 2012.**

He achieved many things during those years including the Foxes Hollow granite entrance plates installed by the Association at the front of the estate.

We have our Christmas Carols planned again this year. We invite residents, their families and friends to join us for Christmas Carols and hot mince pies on Sunday 18<sup>th</sup> December. This year we will have a Christmas Carol procession finishing at the Glessing Road green. This has been very popular in previous years and monies donated have been given to local and national charities.

Final details will be circulated around the estate once times are finalised. Other plans for winter concern ensuring we have enough grit and rock salt to keep the roads clear should we get any cold snaps like last year. In addition to the Parish council grit bins at 2 key points on the estate we also have around 8 volunteers holding our own 600Kg stores of rock salt to cover other parts of the estate. We thank the Parish council for arranging the supply of the bins but by limiting them to only 2 fills per year we hope supplies will last.

Our last main focus is to have the front entrance wall repaired before the worst of the winter weather sets in and we hope the Parish Council can finalise the work to be scheduled at their next Council meeting which unfortunately does not take place until January 2012.

# Winter Advice



Should we get a repeat of last winter's severe weather, residents and businesses can clear snow and ice from pavements, pathways and public spaces without fear of being sued.

Last year many people were put off taking action to clear the area around their properties because they feared they might be sued if passers-by slipped over.

The Government has published guidelines clearly stating there is no law preventing you from doing this; it is very unlikely you would face legal liability as long as you are careful and use common sense.

The following extract from a Ministry of Justice letter may be of interest to anyone who is concerned about their legal position.

*'The prospect of a person who volunteers to clear snow from a pavement being successfully sued for damages by a person who subsequently slips on the cleared area and is injured is very small.'*

*'A snow-clearer does have a duty to anyone who passes along the pavement to do the clearing with reasonable care so as not to create a new and worse risk, but the only person who is at risk of being sued is a person who clears the snow so badly that things are worse than before and that common sense would indicate this was so. A job done very badly indeed which makes the pavement clearly more dangerous than before might give rise to a risk if a person who would not have slipped otherwise slips and is injured as a direct result of that more dangerous state of affairs.'*

# Winter Advice

## Self help

Householders and Businesses in East Sussex are encouraged to clear snow and ice from public areas near their properties during periods of severe winter weather.

They are also encouraged to assist neighbours who may not be able to clear snow themselves.

## Practical Advice

- Start early: it is much easier to remove fresh, loose snow compared to compacted ice that has been compressed by people walking on it.
- Do not use hot water. This will melt the snow, but may replace it with black ice, increasing the risk of injury.
- Be a good neighbour: some people may be unable to clear snow and ice on paths leading to their property or indeed the footpath fronting their property. Snowfall and cold weather pose particular difficulties gaining access to and from their property or walking to the shops.
- If shovelling snow, consider where you are going to put it, so that it does not block people's paths, or block drainage channels. This could shift the problem elsewhere.
- Make a pathway down the middle of the area to be cleared first, so you have a clear surface to walk on. Then you can shovel the snow from the centre to the sides.
- Spreading some salt on the area you have cleared will help to prevent any ice forming. Table salt or dishwasher salt will work, but avoid spreading on plants or grass as they may be damaged by it. A few grams (a tablespoon) for each square metre you clear should work.
- Use the sun to your advantage. Removing the top layer of snow will allow the sun to melt any ice beneath; however, you will need to cover any ice with salt to stop it refreezing overnight.

**The Rock Salt found in Grit Bins will be needed for keeping roads clear.**



## GRIT BIN INSPECTION TIME

They carefully loosened the grit in all 10 bins around the Parish, so that they can be used if we experience any bad weather. Let's hope they are not required!

**CHRISTMAS IS A TIME FOR GIVING BUT  
CRIMINALS JUST WANT TO TAKE**

People in East Sussex who donate clothing to charities are being warned to check the charity first.

As the yuletide period approaches residents across the County may want to give to good causes using charitable collections to donate clothing. However, East Sussex County Council is asking people to be careful who they give to and double check that the charity isn't just one big scam.

Council Trading Standards Officers say that not all the collections are for legitimate charities.

Councillor Carl Maynard, Lead Member for Economy, Transport & Environment said: "Unless you are giving to a recognised charity, the profits from your donation could end up in the pockets of criminals. This is not the most complicated scam in the world but the Association of Charity Shops estimates that between £2.5m and £3m is lost to these scams each year. This is money that could have gone to bona fide charities.

"Our advice would be to be wary of vague statements on packaging with examples including 'donations for work creation' or 'donations to help poor children'. Always check the charity first before you decide to donate."

Trading Standards say that when checking if a charitable collection is legitimate, consider the following:

- Does the bag or leaflet have the number of a registered charity? If so, is there a registered charity number? You can use the Charity Commission website or contact them directly for an up-to-date list of registered charities.
- Check that the registered charity does have a collection service and that it's not some pop-up company claiming it collects for a registered charity.
- Does the leaflet or sack provide contact details? If not this is generally a sign that the collector doesn't want to be contacted because they are not a genuine charity.



Remember that in a power cut mobile phones may not work, but phones that do not have to be plugged into an electric socket will probably still work.

### **GO IN**

To the nearest safe building (if you are not already at home)

### **STAY IN**

The emergency services will expect to collect you from there if any evacuation is needed

### **TUNE IN**

To TV or radio stations for news (use a battery radio or a car radio)

### **WHAT CAN YOU DO?**

MAKE YOURSELF AND THE MEMBERS OF YOUR HOUSEHOLD AS SAFE AS YOU CAN, AND THEN LOOK OUT FOR OTHERS (VULNERABLE PEOPLE) NEARBY WHO COULD DO WITH YOUR HELP.
